



## **Shelter In Place Order 05.7 Extension of Phase III: Staying Safe Lummi Nation**

Effective: April 21, 2021 through May 5, 2021 at 11:59pm

**WHY** As of April 20, 2021, the Lummi Nation has had 509 confirmed cases including 14 active cases and 492 recovered. The recent case spikes across the U.S. are tied to social and family gatherings inside of homes.

### **WHAT PHASE ARE WE IN?**

The LIBC approved Shelter in Place Order No. 05.7 Extension of Phase III: Staying Safe Lummi Nation shall be in effect until May 5, 2021. Below highlights important changes to the Shelter in Place Order.

### **SHELTER IN PLACE ORDER**

Both COVID-19 metrics listed here shall be met before any Phased Reopening advancement. The Phase Reopening metrics will be calculated every 2 weeks, and each phase needs to be in place for at least 2 weeks prior to advancing to the next phase.

Metric 1. Trend in 14-day rate of new COVID-19 cases per 100,000 population: Low Decrease in cases defined by 10% or more; Stable Increase in population defined by 0%-10% increase; and High Increase in population defined by greater than 10% increase.

Metric 2. 7-day percent Positive Result of COVID-19 tests per 100,000 population: Low Positive Result defined by 10% or less; and High Positive Result defined by greater than 10%.

Metric 3. To stay in phase 3, we must maintain less than 30 cases for the past 14 days.

### **SOCIAL DISTANCING**

Every person shall always maintain social distancing of at least six feet from any other person when they are outside their residence as reasonably possible.

### **GATHERINGS**

- Outside gatherings of less than 20 people are permitted.
- Less than 5 people indoors
- Funerals - Follow protocols approved by LIBC
- All congregate activities need to practice social distancing and wear masks/face coverings
- Vaccination is strongly encouraged for any congregate settings.
- Sporting events are permitted and will be held according to the Sporting addendum of the Phase III guidelines.

### **TRAVEL**

Travel related to the provision of or access to Essential Activities, Vital LIBC Functions, and Essential and Authorized Businesses.

All travel shall comply with Lummi Public Health's Post-Vaccine Travel during COVID Policy, with specific regard to fully vaccinated individuals. Fully vaccinated individuals may travel outside Washington 14 days after receipt of their second vaccination or 14 days after receipt of approved single dose vaccination. Non-vaccinated individuals who travel out of state to an area with greater than 200 cases per 100,000 individuals must quarantine for 10 days after returning. A negative test must be taken between the 7th and 10th day of return.

## **VACCINATION – GET VACCINATED**

### **FACE COVERINGS**

Every person must wear a face covering that covers their nose and mouth when in any indoor or outdoor public setting except in the following:

- When they are eating or drinking,
- When communicating with a person who is deaf or hearing impaired and not wearing a face cover is essential to communicating;

People who don't need to wear a mask:

- Children under the age of six,
- Others who wearing a mask may be difficult due to medical illness or intellectual disability.
