22 The request is granted, and the following order is entered:

23 1. The Petitioner is allowed to enter the boundaries of the Lummi Indian Nation for the
24 purpose of repossessing the above-described property.

25 2. The Respondent shall relinquish the above-described property to the petitioner or
designated agent.

3. Lummi Law & Order shall stand by to keep the peace if requested.

1 4. THIS ORDER SHALL BECOME INVALID THIRTY (30) DAYS FROM THE DATE
2 OF ISSUANCE AND MUST BE RENEWED THEREAFTER.
