Eligibility Requirements are based off the Lummi Constitution and Bylaws, Art. II - Membership, Sec. 1a through 1f, Lummi Code of Law, Title 34-Enrollment.

Ref. 34.04.030 - Lummi Code of Law, Membership Restrictions includes, not allow dual enrollment with other Federally Recognized Tribes, does not allow re-applying after one has relinquished as an adult.

Applicants must provide the following:
☐ Enrollment Application must be completed, signed, and dated
☐ Release of Information form must be completed, signed, dated, and notarized by a Notary Public
☐ Family Tree form must be filled out completely; all female(s) listed use only their maiden names
\square DNA required for all parties (i.e., child, mother, and father); fees are due upon receipt of application
\square Certified Birth Certificate, Original Only
\square Verified Indian Blood Degrees of other affiliated Tribes
\square Enrollment Status Report from any other Affiliated Tribes
Other Support Documents (i.e.: certified Marriage Certificate, legal name change, court ordered custody)
☐ Contact information up to date (i.e.: phone number(s), email address, and/or mailing/physical address)
\square Any other information required will be identified by the intake enrollment specialist
<u>Timeline of Enrollment Processing:</u> Once all information is collected and criteria are met, the
application will be placed on the next agenda for the Enrollment Committee.

lacktriangle Applications need to be submitted in a timely manner allowing intake process to take place.
