JOB SUMMARY: The Dispensary Licensed Practical Nurse (LPN) will provide direct support to the medical staff of the Lummi Healing Spirit Clinic Opioid Treatment Program and be responsible for dispensing medications to clients per provider orders and in accordance with program policies, procedures, and phases of recovery.

ESSENTIAL JOB DUTIES AND RESPONSIBILITIES include the following, plus other related duties as assigned:

1. As member of the Lummi Healing Spirit Clinic, help provide medications for outpatient maintenance and detoxification treatment services to those recovering from addiction.
2. Provides outpatient-nursing services support related to care coordination.
3. Accurately and efficiently helps dispense daily doses of methadone, buprenorphine, and naloxone as indicated by the Medical Director.
4. Manages dispensary medication inventory, and client dosing records including prospective dosing appropriately.
5. Maintains and enforces HIPAA and 42 CFR Part 2 regulations.
6. Maintains clear and concise medical records within Methasoft and Central Registry, including checking WA-PMP and to monitor for dual enrollment for compliance with OTP certifying agencies.
7. Attends weekly staff meetings, planning and training meetings, workshops, and conferences.
8. Maintains the minimum requirement of professional continuing education credits annually on topics related to nursing and addiction.
9. Maintains ability to pass a drug and alcohol test as required by the Drug and Alcohol Free Workplace Policy.

KNOWLEDGE, ABILITIES AND SKILLS:

- Excellent oral and written communication skills in dealing with patients and family members, paraprofessionals, and other staff members.
- Ability to establish and maintain cooperative and supportive relationships with program participants.
- Ability to independently perform a clinical assessment, implement nursing care measures and to report and document findings.
- Understands HIPAA and 42 CFR Part 2 confidentiality requirements for health care.
- Demonstrates a foundational knowledge of nursing skills, knowledge of the basic principles, practices, and standards of care for adolescent and adult patients.
- Demonstrates computer skills including word processing software, communicating through electronic messaging, and obtaining information when needed from the Internet.
- Ability to work in a cross-cultural environment. Understands the social and cultural context of American Indian/Alaska Native culture.
- Possesses a treatment-integrated understanding of historical trauma and Native cultural values.
- Drives a car and possesses a valid Washington State driver's license.

ORGANIZATIONAL RESPONSIBILITIES

- Maintain strict confidentiality in all work-related areas, process all client information and activities in a confidential manner consistent with the Lummi Nation's Policies. Knowledgeable of HIPAA requirements and 42 CFR Part 2 regulations
- Participate in staff and program meetings, including consultation and professional training sessions as required by their supervisor.
- Must be able to develop an appropriate and professional relationship with other services providers, consultants, and outside agencies when necessary.
- Understanding of the Lummi/Native American/Veterans Preference Policy applies.
- Must have a valid Washington State Driver's License and be eligible for Tribal Insurance.

MINIMUM QUALIFICATIONS:

- Requires a valid Washington State License as a Licensed Practical Nurse.
- Professional work experience in Native communities is desirable.
- Professional work in addiction medicine and an Opioid Treatment Program desirable.
- Must possess a valid Washington State Driver's License and meet eligibility requirements for tribal insurance.
- Lummi/Native American/Veteran preference policy applies.

REQUIREMENTS:

- Must pass pre-employment and random drug and alcohol test to be eligible for and maintain employment, as required by the LIBC Drug & Alcohol Free Workplace Policy.
- Position requires Criminal Background Check.
- Prior experience working with adolescents and adults.
- Prior experience working with chemical dependence issues.
- Has a valid Washington State License as an LPN.
